

NOTIFICATION FOR COUNSELLING

This is for information of all concerned that 2nd counselling for admission to the Diploma courses in Tripura Institute of Technology, Narsingarh, Women's polytechnic, Hapania, Dhalai District Polytechnic, Ambassa, Gomati District Polytechnic, Udaipur, North Tripura District Polytechnic, Dharmanagar and TTAADC Polytechnic Institute, Khumulwng along with 45 (Forty Five) numbers of Government of India seats in West Bengal, Guwahati and Arunachal Pradesh will be held at **RAVISHANKAR AUDITORIUM, TRIPURA INSTITUTE OF TECHNOLOGY, NARSINGARH, on 3rd August 2019(Saturday)** from 11:30 Hrs to 16:30 Hrs. Details of branch and institute wise vacancy of seats after 1st counselling and admission will be available in the website www.titagartala.ac.in on or after 1st August 2019.


It should be carefully noted that:

1. Counselling will be strictly on the basis of merit and reservation policy adopted by the Government of Tripura.
2. Delayed reporting by a candidate will cause loss of merit seniority. Such candidate will be eligible for counselling among the rest available seats in his/her category at the time of reporting.
3. Nomination of candidate is provisional. Any discrepancy/shortfall found in relevant documents at any stage of counselling and also at later stage even after admission may lead to cancellation of nomination/Admission of the candidate.
4. Nominated/selected candidate must take admission within the date specified in nomination letter in the Institute where he/she has been allotted a seat.
5. During the counselling session there is no provision for change of branch or Institute, once a particular seat is opted and allotted to a candidate. A candidate may opt not to accept the seat allotted to him/her according to his/her merit position, in such cases the candidates may appear for next phase of counselling if any takes place. The candidates may surrender that seat even after allotment of the seat up to the last date of admission mentioned in the letter of nomination to the respective Institution. In such cases, he/she may appear for next counselling.
6. Eligible candidates are further advised to visit www.titagartala.ac.in at regular intervals to be aware of updates, if any.
7. Physical appearance of the candidate is compulsory for seat allotment failing which he/she will not be allotted any seat in the counselling.
8. All the candidates are directed to bring all related documents in original with one set of photocopy failing which selection will not be considered.
9. Nomination of the candidates who do not take admission nor surrender the seat within the date specified for admission in the letter of nomination will be deemed to be cancelled and they will not be considered for admission in this session.
10. Only one guardian of the candidate is allowed to accompany with the candidate inside the counselling hall.
11. In case the counselling cannot be completed within the specified date and time in such case venue and schedule of counselling of remaining applicants will be declared on the last day of the counselling.
