MINUTES OF THE 15th MEETING OF THE BOARD OF GOVERNORS HELD ON 9th June, 2020 AT TRIPURA INSTITUTE OF TECHNOLOGY

After detailed discussions, following decisions are taken by the BOG which are mentioned item wise.

Item No.15.1 Confirmation of the minutes of 14th BOG meeting.

The minutes of the 14th BOG meeting as circulated to all concerned were placed for confirmation and accepted by the Board.

Item No.15.2 Ratification of some decisions approved by the Chairperson for implementation of TEQIP-III Project as per delegation of power.

The House has ratified the approval accorded by the Chairperson for re-engagement of 03(three) support staff namely 01(one) Manager (IS), 01(one) Accountant and 01(one) Office Assistant engaged under TEQIP-III Project (TIT) for a period of 06(six) months from 22-01-2020 to 21-07-2020 on contract basis.

Item No.15.3 Ratification of some decisions, approval and sanction of funds by the Principal for implementation of TEQIP-III Project as per delegation of power.

The Institute Authority has confirmed that all the expenditure and activities are made as per the prevailing norms of World Bank Project, TEQIP-III. Hence, 09 (Nine) items of procurement of equipments amounting total Rs.93,67,127.00.; academic activities under 09(Nine) heads amounting total Rs.32,88,713.00 and expenditure from IOC head under 05(five) nos. of sub-components amounting total Rs.20,71,883.00 and 01(one) no. PO issued through Non-PMSS from IOC head amounting Rs.7,12,347.00 for implementation of TEQIP-III Project as per delegation of power conferred in 9th BOG meeting have been ratified by the House in view of compliance of TEQIP rules.

Item No.15.4 Present status of ongoing TEQIP-III Project as on 31-03-2020.

The House has noted about the present status of TEQIP-III.

Item No.15.5 Fee Structure of M. Tech. Programs.
